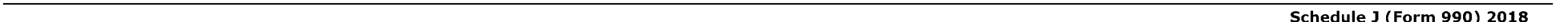

KEY EMPLOYEES ARE REQUIRED TO COMPLETE AND UPDATE THE FORM ANNUALLY. IN MAY OF EACH YEAR, THE LIST OF KEY EMPLOYEES IS ANALYZED AND UPDATED AS NECESSARY BY THE INTERNAL AUDITOR WITH THE ASSISTANCE OF THE VICE PRESIDENT FOR PLANNING AND FINANCE. IN DECEMBER OF EACH YEAR, THE FORMS ARE SENT TO THE INDIVIDUALS IDENTIFIED AS KEY EMPLOYEES. THE COMPLETED FORMS ARE THEN ANALYZED BY THE INTERNAL AUDITOR, CONTROLLER, AND VICE PRESIDENT FOR PLANNING AND FINANCE AND A SUMMARY IS PREPARED OF ANY RELATIONSHIP DISCLOSED. BOTH SUMMARIES ARE THEN PRESENTED TO THE AUDIT SUBCOMMITTEE OF THE BOARD OF TRUSTEES AT THE FEBRUARY MEETING.
