In fiscal year 2018-2019 PAAR served over 3,100 clients through various trauma modalities to help victims heal from sexual violence. PAAR has seen an increase in survivors seeking individual trauma therapy for sexual abuse. PAAR's helpline volunteers and advocates respond 24/7 to victims in crisis from sexual violence. PAAR's legal advocacy clients continue to increase as do the victims seeking help in area hospital emergency rooms. PAAR also provided prevention/education programs to over 22,000 individuals in Allegheny County. PAAR also established satellite offices in Allegheny County so services are more accessible to victims throughout Allegheny County.
