In 2020, PASA hosted our 29th annual Sustainable Agriculture Conference, attended by 2,100 farmers, agricultural professionals, and food systems supporters. This event continues to be one of the premier sustainable agriculture conferences in the country and attracts a diverse cross section of stakeholders working to grow a more sustainable food and farming culture.

We coordinate one of the most extensive and well-attended calendars of Farmer-to-Farmer Exchange events in the region. This past year we offered 53 events that were attended by more than 1,300 people. These are accredited, first-in-the-nation programs that offer a structured career path for beginning farmers through a combination of paid, on-the-job training and technical instruction.
