Authors, exhibitors and book lovers of all kinds attended the Festival which attracted approximately 140,000 people to the UA campus and raised \$165,200 to advance literacy and education in Southern Arizona. The 2019 Festival attracted more than 550 authors (presenting and indie), 330 exhibitors and staged a multitude of activities: hundreds of presentations and discussions, workshops for aspiring authors, book signings, free book give-away distribution of 6,000 titles in the Childrens area, dozens of hands-on activities were conducted in Science City, and much, much more.
