Self-identifying girls and non-binary students in grades K-12, and college from all backgrounds interact with professional women in technology careers during the school day. Young women and non-binary students glimpse themselves as innovators and entrepreneurs through stories of successful women who work and live in their communities. Working with teachers, IGNITE increases girls and non-binary students interest and participation in computer science and engineering classes. With the growth and positive outcomes IGNITE has created, a demand for the program in elementary schools and colleges has arisen. IGNITE's mission now encompasses girls and non-binary students at every level of their education.
