We have served a total of 1,152 youth through our success skills programs. 90% of our youth have either earned a high school diploma or are on track to earn a high school diploma or GED. 61% of our youth who have graduated high school are on track to earn a higher education degree or certificate. 78% of our youth have held paying jobs or are currently employed. In addition, we reached approximately 5,250 youth indirectly through distribution of youth guides and materials and staff training for collaborating agencies.
