 CCMA mobilizes the collective commitment of and capacity of higher education to actively advance our communities through civic and community engagement throughout the Maryland, DC and Delaware region. CCMA serves its member institutions through networking, grants, resources and programs with the goal of developing deeper campus-community partnerships which improve community life.

 CCMA AmeriCorps VISTA grant CCMA addresses and alleviates poverty in the Maryland-DC-Delaware region through the federally funded CCMA AmeriCorps VISTA Grant --> <https://midatlantic.compact.org/grants-and-awards/ameriCorp-vista/>  
 Through this grant CCMA provides up to 39 full time "positions" to develop and expand anti-poverty partnerships between higher education institution members and community-based organizations, non-profits, or local schools and school systems in the region. Through data from the annual survey, CCMA estimates that member institutions' students contribute a minimum of \$600 million in services annually to the region. The VISTA grant alone is a value of approximately \$2 million to our members. Our projects represent a smorgasbord of foci ranging from financial literacy, workforce development, mentoring, veteran initiatives, ESOL programming, college access, college completion, to food security. CCMA also develops and runs a leadership and professional development program for the AmeriCorps members who are giving a year or more of their lives to build these partnerships and improve our communities. CCMA VISTA projects expand the capacity of regional non-profits and institutions of higher education to transform and empower first-generation college students, community members, and K-12 youth.

 P20 Connects and PeaceJam Grant.  
 To advance CCMA's P20 CONNECTS initiative, CCMA was awarded an AmeriCorps planning grant from the Corporation for National and Community Service to advance college, career, and civic readiness in the region by creating a local affiliate of the international PeaceJam program ([www.peacejam.org](http://www.peacejam.org)). The successful planning grant allowed CCMA and PeaceJam to determine that the best fit for this initiative was to create a unique partnership with Montgomery County Public Schools (MD), the District of Columbia, CCMA institutions, and multiple other entities in the region, as PeaceJam Mid-Atlantic launches independently in FY2020. PeaceJam includes an academic curriculum for K12 schools and an annual PeaceJam Youth Conference. The highlight of the annual PeaceJam Conference is hosting a Nobel Peace Prize Laureate who speaks with K12 and college students for a weekend about building leadership and service programs. CCMA's P20 CONNECTS initiative expanded substantially in FY2019 with five Pilot Partnerships, a Leadership Team, an Assessment Team, an Empowerment Learning Module and an Orientation Program.

 Professional development institutes, workshops, retreats, awards, surveys, mini-grants, and support to member institutions:  
 Another area of CCMA's impact is providing professional development opportunities for faculty, staff, students and other constituents in its membership. CCMA currently sponsors a Service-Learning and Civic Engagement (SLCE) Conference for 300+ faculty and students, annual retreats including a "Practitioners' Retreat" for engagement professionals, and numerous workshops on service-learning, grant writing, effective team building, volunteer recruitment, professional writing and (federal) report writing, linking civic engagement with accreditation, etc. CCMA provides mini-grants to promote faculty development, building a culture of engagement on a campus, community-based learning and rewarding the scholarship of engagement in the promotion and tenure process. CCMA also provides competitive mini-grants for student groups which wish to expand a program with a community partner organization. CCMA coordinates an annual awards program which highlights exceptional leadership and work in the area of service-learning and civic engagement, and administers national award programs (such as the Campus Compact Newman Civic Fellowship award). Finally, CCMA administers an annual member survey and co-sponsors other regional and national conferences.
