With the 2018 theme, Transforming Our Community, ConveneNV recognized the resiliency of a truly galvanized community and focused on two of the greatest challenges facing Southern Nevada: homelessness and trafficking. All businesses, public entities, NGOs, and residents, acting in collaborative partnership toward aligned goals, can take the bold and transformative steps needed to shift the community to a more sustainable and resilient path. It is a collective journey that builds off of previous regional goals established at past Convene for Green summits as well as the great work already being done in the community. ConveneNV, Transforming Our Community, will stimulate action over the next year in these areas of critical importance for all Nevadans.

Form 990, Part III, Line 4c:

Building Bridges - In 2018, ImpactNV continued our model of collaboration and community convening through a new program series called Building Bridges, focused on bringing together the NGO, academic, public, and private sectors around addressing human trafficking in Southern Nevada. Throughout the year, we held a series of events and workshops. The first was held in August for the nonprofit and academic sectors and focused around imagining the ideal counter trafficking system in our region what needs to be done in the short and long term to address current gaps. From September through December we met with and convened department heads and jurisdictional leadership to discuss the trafficking landscape, and how each department can engage in filling in the gaps from the victim service and demand reduction side. In November, we held a workshop for the private sector focused on the gaming, healthcare, banking, and transportation industries where we reviewed the current landscape, the business case for community investment, as well as what can be done by the private sector internally at the corporate level and through philanthropy and community investment.
