Purchase of necessary replacement and/or new equipment for the Cypress Ranch High School Theatre Arts Department to provide continued high-quality productions for the benefit of Cypress Ranch Theatre students and families, as well as our Cypress, TX community. Key purchases this year included projector and mount, Eartec HUB8S-HD, aerial loops, and digital piano and accessories.

Education Trips
Revenue from education trips includes student payments towards their expenses and Cypress Fairbanks Independent School District reimbursement for 1/2 of registration fees for the National Thespian Festival. In June 2019, these students traveled to National Thespian Festival held at The University of Nebraska in Lincoln, Nebraska.
Expenses include transportation, lodging, registration, and competition fees.
