Will Kemp Returns: A Jigs Revival. A concert which featured staged and costumed performers reenacting the Jigs, short musical comedies, popular with both the court and the commons in the time of Shakespeare.

A Mexican Christmas: Angels in the Convent, Dancing in the Streets. In 17th Century Mexico, people would gather outside the convents to hear the singing of the cloistered nuns often juxtaposed with popular street music. This concert recreated that unique combination using music found in partbooks of the Convento de Nuestra Senora de la Encarnacion now in the collection of the Newberry Library. The street music was drawn from those Villancicos sung at Christmastime in 17th century Mexico.
