CACTUS LEAGUE ACTIVITIES HAVE A MAJOR FINANCIAL AND SOCIAL IMPACT ON THE TOURISM INDUSTRY IN MANY CITIES AND TOWNS IN ARIZONA. MAJOR GOALS OF THE ASSOCIATION ARE TO ESTABLISH AND NURTURE BUSINESS RELATIONSHIPS WITH MAJOR LEAGUE BASEBALL FRANCHISES THAT CONDUCT PLAYER DEVELOPMENT ACTIVITIES IN ARIZONA, TO VOICE OPINIONS ON LEGISLATIVE ISSUES OF INTEREST TO ASSOCIATION MEMBERS, AND TO FACILITATE AND ENCOURAGE AND PARTICIPATE IN ACTIVITIES DESIGNED TO PROMOTE THE CACTUS LEAGUE.
