HHF HAS SEVERAL OTHER PROGRAMS THAT IT SUPPORTS COMMUNITY NUTRITION PROGRAM - THIS PROGRAM PROVIDES SUSTAINABLE ALTERNATIVES FOR OBESITY PREVENTION AND PROMOTES HEALTHY LIFESTYLES BY INCREASING ACCESS TO NUTRITIOUS FOOD. THE INITIATIVE AIMS TO PROVIDE EASIER ACCESS TO AFFORDABLE FRUITS AND VEGETABLES IN HOUSTON COMMUNITIES THAT ARE CONSIDERED FOOD DESERTS. THESE AREAS ARE CURRENTLY UNDERSERVED BY GROCERY STORES AND OTHER FRESH FOOD OUTLETS. THIS EASIER ACCESS IS ACCOMPLISHED BY ORGANIZING FARMERS MARKETS IN UNDERSERVED INNER-CITY NEIGHBORHOODS. A TOTAL OF OVER 4,500 POUNDS OF FRESH PRODUCE WAS MADE AVAILABLE TO LOCAL PEOPLE IN THESE AREAS. THE PROGRAM ALSO HOSTED 57 FARMERS MARKET EVENTS. COMMUNITY OUTREACH - HOUSTON HEALTH FOUNDATION SUPPORTS THE CITY OF HOUSTON'S VACCINATION CAMPAIGN AND PROVIDES TECHNICAL ASSISTANCE ON THE TEXERCISE SELECT RESEARCH STUDY HOUSTON RECOVERY INITIATIVE (HRI) - HHF IS FACILITATING THE STRATEGIC PLANNING FOR HRI THROUGH FISCAL MANAGEMENT AND GRANT MANAGEMENT SERVICES. HRI IS TRANSFORMING HOW WE THINK ABOUT RECOVERY, MOVING FROM EPISODES OF TREATING THOSE AFFECTED BY ALCOHOLISM AND ADDICTION INTO A LARGER RECOVERY-ORIENTED CONTINUUM OF CARE. HRI CREATES OPPORTUNITIES TO COLLABORATE WITH AGENCIES ACROSS HOUSTON, WORKING TOGETHER TO AID THOSE IN OUR COMMUNITY AFFECTED BY SUBSTANCE MISUSE. MY BROTHER'S KEEPER IS PART OF A NATIONAL MOVEMENT TO IMPROVE OUTCOMES AND REDUCE OPPORTUNITY GAPS FOR BOYS AND YOUNG MEN OF COLOR. THE HOUSTON HEALTH FOUNDATION HAS BEEN INSTRUMENTAL IN THE DEVELOPMENT OF THE TEAM UP PROGRAM WITHIN MBK, WHICH IS DESIGNED TO MOTIVATE YOUTH AND KEEP THEM ON A PATH TOWARD COLLEGE BY LEVERAGING THEIR LOVE OF SPORTS. THIS PROGRAM, THOUGH STILL IN ITS INFANCY, HAS IMPACTED OVER 250 STUDENTS WITH 94% REPORTING THAT THEY HAD A BETTER UNDERSTANDING OF WORKING IN A PROFESSIONAL SETTING. 96% OF OUR PARTICIPANTS ASPIRED TO ATTEND COLLEGE. IN ADDITION, HHF HAS BEGUN TO COLLABORATE IN SUPPORT OF HOUSTON BASICS, AN EARLY CHILDHOOD BRAIN DEVELOPMENT INITIATIVE THAT ADDRESSES MILESTONE I WITHIN MBK.
