Off-site tours included trips to the National Eagle Center, Jeffers Petroglyphs, Lower Sioux Historic Site, Mille Lacs Indian Museum and historic Fort Snelling. Main days of programming were on the 10th and 11th with over 150 sessions offered. Note that there is an overlap between years as the conferences are held in October. The 2019 International Conference of Indigenous Archives, Libraries, and Museums will take place in Temecula, California (outside San Diego) on October 8-10, 2019. Conference attendance is expected to be 900. Programming will include hands-on preconference workshops, off-site tours to local tribal cultural sites and over 140 sessions devoted to topics relevant to tribal archives, libraries, and museums.
