Ratio Christi's University Apologetics Program During Jan-Jun of 2019, Ratio Christi had over 130 chapters in operation. The average chapter serves anywhere from 10 to 20 students, making an impact on the over 2,000 students who participate in weekly meetings on campus. We also held public events at many of these campuses, reaching as many as 200 to 300 or more at each event. Ratio Christi also continued to redesign our web site, making our reach worldwide. We implemented a strategic plan for long term financial stability, which includes supported missionary apologetics on campuses, adding 3 more missionaries in Jan-Jun of 2019. We have relationships with ten major seminaries and dozens of apologetics ministries in the U.S.
