The recipient and the organization then work through a process to develop the contract by which the recipient and the organization are bound. All the certified local government grants must produce a product of some kind. Therefore, the monitoring of the product development is dependent upon the project type. This includes submission of specifications prior to work, progress or draft reports submitted, and final reports along with a variety of completed forms depending on the project. Each grant/project is significantly monitored to ensure that the product or work meets the Secretary of the Interiors standards. The History Fund is about preserving and sharing Ohios heritage by supporting local projects and programs that strengthen Ohio history. The History Fund is a competitive Matching Grants Program that is one of four tax check-off funds found on Ohios Income tax forms and funded entirely through Ohio taxpayers voluntary contributions.

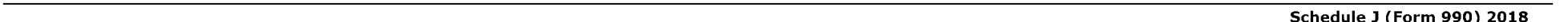
