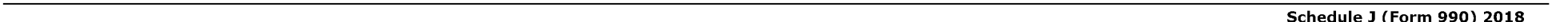

CONFLICT OF INTEREST POLICY IS STATED IN THE PERSONNEL HANDBOOK FOR EMPLOYEES WHO ARE TO SIGN AN ACKNOWLEDGMENT STATING THEY HAVE READ AND WILL COMPLY WITH THE POLICIES COVERED BY THE EMPLOYEE HANDBOOK.
