EUSD has the contracts with Teachers and Programs for Instruction in Technology, Science, Math, Art, Reading, Garden Science & Nutrition, Language, Health and Wellness, etc. EEF also sends EUSD funds to reimburse them for the resources to support these Teachers and Programs like Science Equipment, Art Materials, PE Equipment, etc. Each school site/chapter agrees to the need of Enrichment Teachers and Programs on an annual basis based on their prior year fundraising efforts. The Principal, School Site Council, and EEF Advisory Committee agree on what programs are most need for their individuals sites/chapters and therefore which Enrichment Teachers/Programs are needed. The EEF Advisory Committee is governed by the EEF Bylaws.
