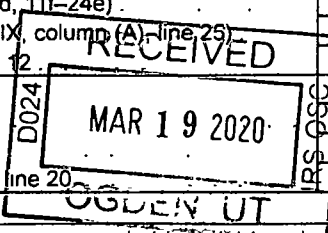

1 Briefly describe the organization's mission: The Ignatian Solidarity Network (ISN) networks, educates, and forms advocates for social justice animated by the spirituality of St. Ignatius of Loyola and the witness of the Jesuit martyrs of El Salvador and their companions. As of June 30, 2019, ISN had over 100 member institutions and a database of over 40,000 individual contacts.

4a (Code: ) (Expenses \$ 135,888 including grants of \$ ) (Revenue \$ ) HUMAN RIGHTS ISSUE EDUCATION, SOCIAL ACTION, AND ADVOCACY PROGRAMS: Ignatian Family Teach-In for Justice - In November, nearly 2,000 individuals from more than 150 institutions across the Jesuit and greater Catholic network gathered in Arlington, Virginia and Washington, D.C. for the 21st annual Ignatian Family Teach-In for Justice and Advocacy Day. The weekend empowered leaders, illustrating the ways in which each individual life and sphere of influence can build momentum toward justice and hope, from the very personal to the global. Teach-in attendees represented over 30 U.S. states, Canada, El Salvador, and Mexico, including over seventy Jesuit universities, high schools, and parishes. Not only did attendees grow in their knowledge of a wide range of social justice issues facing society today, they also had the opportunity to deepen their faith life through prayer and reflection; network with peers and colleagues from throughout the hemisphere, and take action as legislative advocates. 4b (Code: ) (Expenses \$ 256,166 including grants of \$ ) (Revenue \$ ) FAITH-BASED SOCIAL JUSTICE LEADERSHIP DEVELOPMENT & AFFIRMATION: Arrupe Leaders Summit - ISN hosted three leadership summits for high school students and faculty across the country in Spring 2019. Named after the late Pedro Arrupe, S.J., former leader of the Jesuits internationally, the Arrupe Summits offer students and teachers the opportunity to explore the relationship between service, social justice, faith, and leadership. Over 100 students and 40 faculty members from Jesuit and partner Catholic high schools across the U.S. and Canada participated in the summits which took place in California, Ohio, and Maryland. Ignatian Justice Summit - In July of 2018, 42 students from 15 Catholic universities, including 14 Jesuit universities, gathered on the campus of John Carroll University for the annual Ignatian Justice Summit (IJS). The Summit focused on the timely issue of immigration in an Ignatian context—with programming preparing students to organize and lead immigration advocacy efforts on their campuses. 4c (Code: ) (Expenses \$ 166,985 including grants of \$ ) (Revenue \$ ) COMMUNICATIONS AND NETWORK: Education for Justice - In January 2019, ISN acquired "Education for Justice" (EFJ) an award-winning global digital subscription membership service providing resources for those who wish to study, teach, and practice Catholic social tradition. Originally a project of the Center of Concern, established by Pedro Arrupe, S.J., and Joseph Cardinal Bernardin in 1971, EFJ found a new home at the Ignatian Solidarity Network in early 2019 after the Center closed its doors in November 2018. Since 2001, EFJ has helped teachers, social action directors, parish members, campus ministers, and others in leadership roles to meet the challenge of sharing Catholic social tradition with wide audiences. Solidarity on Tap - In partnership with Jesuit Volunteer Corps and Jesuit Volunteer Corps Northwest, ISN hosted hundreds of young adults at Solidarity on Tap at 24 events across the country, taking place in 15 different U.S. cities. Form 990, Part III, Section 4a, On the Monday following the Teach-In, more than 1,500 of the attendees met with over 125 Congressional offices to discuss humane reforms to immigration and criminal justice policy. At the root of our work is a commitment to forming leaders and advocates rooted in a firm belief in the dignity of all people. This commitment is particularly made manifest in our immigration work through opportunities for transformation through education, encounter, advocacy, and the vital act of truly hearing the stories of those who migrate. Virtual Teach-In on Migration - On March 2, 2019, ISN hosted the first Virtual Teach-In on Migration, an opportunity for the Ignatian family across the U.S. to gather digitally for dynamic speakers, prayer, and reflection opportunities exploring the realities of migration—both on the border and in communities across the country. Campaign for Hospitality - ISN harnessed the power of social media through mini-campaigns designed to draw the Ignatian family deeper into solidarity and action for and with those who migrate. Mini-campaigns often center around key dates, like the Feast of Our Lady of Guadalupe social media campaign; current issues, including the Light in the Darkness Campaign, addressing family separation at the U.S.-Mexico border through prayer, solidarity, and legislative advocacy; or local community events, including the Come to the Table campaign, designed to bring communities together through international potlucks. Partnerships - ISN is committed to partnerships with the greater Ignatian network as a means to change making through collaboration on immigration issues. During the past year, ISN collaborated with the Jesuits to convene the Jesuit Migration Network of U.S. and Canada, supported the efforts of a broader Jesuit network throughout Mexico and Central America. Encounter - In January of 2019, thirteen members of Jesuit parishes across the U.S. joined ISN in El Paso, Texas for Seeking the Grace of Encounter, a border immersion, facilitated by The Encuentro Project. Participants were offered opportunities to encounter and minister to migrant, refugee, and vulnerable immigrant individuals in shelters and a detention center in the area. Prayer and reflection each day served to allow participants to analyze their experience of migrant and border realities
