Becky's Place is designed to "provide shelter and create hope" for women and children who are experiencing homelessness and moving toward a life of self-sufficiency. Becky's Place offers several services to its residents such as case management, budgeting classes, support group, weekly house meetings, referrals for services, transportation, and life skills are also provided. Becky's Place provides bus tokens, computer access, phone access, three meals per day, clothing/shoes, and hygiene items to its residents. From July 1, 2018 to June 30, 2019, Becky's Place served 69 women and 42 children. 34 women and children stayed an average of 30 days or less, 13 women and children stayed for 31-60 days and 54 women and children stayed longer than 61 days or longer. 59 of the women and children exited in to permanent housing. 16 women exited to emergency shelter, temporary stay with family/friends, jail, a hotel/motel, or a hospital stay.
