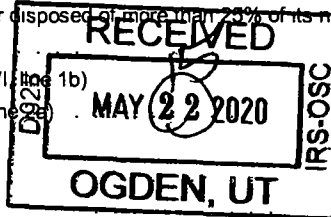

The Aurora Commons offers the only drop-in space on North Aurora directly serving women who are commercially sexually exploited, many of whom are drug dependent. We have developed relationships with over over 300 women who work along Aurora, with 6376 visits to the Commons; 287 new neighbors visited the space. We matched 22 people with housing and helped 122 people gain access to addiction treatment. On Wednesday evenings and Thursday afternoons, the Commons makes available, for female identifying clients, the Safe Healthy and Empowered (SHE) Clinic run by UW Medicine. The purpose of the SHE Clinic is to provide kind, quality, nonjudgmental healthcare to women on Aurora Avenue. SHE served 128 women in 2019. (continued on Sch O)
