The Society operates early childhood education centers in the Chicagoland area with total capacity to serve 218 children. The Society also provides homes based early childhood services to support children and their families from prenatal to 3 years funding capacity for 342 families. The home based programs work to support the parent-child attachment through various activities facilitated by home visitors/family advocates. Home based services are offered through the Chicagoland area and across South Suburban Cook County.

The Youth and Family Empowerment division provides multiple levels of support to help families stay intact and thrive in their communities.
