SECTION 4. VACANCIES

A.EXECUTIVE BOARD: ANY EXECUTIVE BOARD POSITION WHICH BECOMES VACANT WILL BE FILLED BY EXECUTIVE BOARD APPOINTMENT AND SUBJECT TO CONFIRMATION OF THE GOVERNING BOARD.

B.GOVERNING BOARD: ANY VOTING POSITION ON THE GOVERNING BOARD, WITH THE EXCEPTION OF EXECUTIVE BOARD MEMBERS AND CHAPTER REPRESENTATIVES, SHALL BE APPOINTED BY THE PRESIDENT WITH THE APPROVAL OF THE EXECUTIVE BOARD. CHAPTER REPRESENTATIVES SHALL BE REPLACED BY THEIR REGIONS.
