Molecular Physiology and Pharmacology of ATP1A3 Mutations in AHC: \$243,644 grant awarded to Dr. Alfred George, Jr. at Northwestern University and Dr. Kevin Ess at Vanderbilt University to investigate the functional consequence of AHC gene mutations, to identify drugs or drug-like compounds with potential therapeutic effects in restoring normal gene function, and to develop advanced human cell models of AHC based on state-of-the-art induced pluripotent stem cell technologies.

4b (Code:) (Expenses \$ including grants of \$ 75,446) (Revenue \$)
Aim 1: To determine the effects of various approved drugs and experimental compounds on AHC feature in D801Y mice. The goal of this project is to complete the ongoing investigation to determine if any specific drugs or experimental compounds can prevent cold-induced attacks of weakness and dystonia in D801Y mice.
Aim 2: To measure the pump current in neurons from D801Y mice. In previous experiments AHC neurons exhibited impaired sodium-potassium pump activity that could be directly measured as 'pump current' and provided the first direct evidence at ATP1A3 loss of function in a human neuron. The goal of this aim is to make similar measurements in neurons from D801Y mice then compare ATP1A3 function between mouse and human neurons.

4c (Code:) (Expenses \$ including grants of \$ 30,000) (Revenue \$)
Aim 1: Perform a retrospective analysis of all available medical records and parent reported data from individuals with AHC and other ATP1A3-related neurologic phenotypes who have previously consented enrollment in the database in order to establish a natural history dataset across the lifetime.
Aim 2: Continue to maintain a permanent bio-repository of cells, tissues and other biological materials from AHC patients to help facilitate ongoing basic research efforts to identify and validate promising new therapies, and to share with other investigators interested in performing collaborative basic studies.
