PART I QUESTION 1	<p>The Funders Collaborative was established to deploy funds to schools in need of additional resources to improve the quality of education for students of Newark. Funds received from foundations are credited to the appropriate account for future disbursement. The account is a Restricted Fund. All awards from those funds must be approved by the Executive Director using recommendations from the Governance Committee and NTE internal review committee. The South Ward Community Schools Initiative (SWCSI) unites educators, families, and community partners to be responsible for five specific schools in Newark's South Ward. NTE submits a proposal to Community Foundation of New Jersey (CFNJ) with a proposed budget developed by each school for the school year. CFNJ issues a grant to NTE for the continuation of SWCSI activities in the five schools for the school year. The Abbott Leadership Institute (ALI), in partnership with the Newark Trust for Education, provides a five-week training on Parent Engagement through Social Emotional Learning for Newark parents and caregivers across five schools. The training is designed to give parents the tools needed to support their children's social and emotional competency development while also assessing their own social and emotional challenges and methods to overcome them. ALI submits a proposal together with an itemized budget which is approved by the Executive Director. All receipts to the Funders Collaborative and SWCSI are recorded as revenue in separate Cash Accounts and identified as restricted funds. All grant awards from these funds are tracked in subsidiary ledgers that identify disbursements by date, Grantee, Foundation and Dollar amount. A Sub Ledger/Summary is prepared monthly for each initiative, identifying the date, Grantee, Foundation, disbursements and balances. Award letters specifying the grant amount for each school/organization under the Funders Collaborative, SWCSI and ALI are approved by the Executive Director and issued to grantees along with a check. Schools/Organizations without a financial conduit draw down against their grant award by submitting payment requests to the Trust as needed. Follow-up visits, post evaluations, and final narrative and financial reports are communicated back to Governance Committee (Funders Collaborative), CFNJ (SWCSI), and Abbott Leadership Institute, respectively.</p>

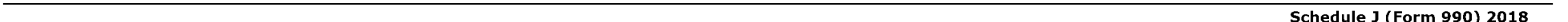
