

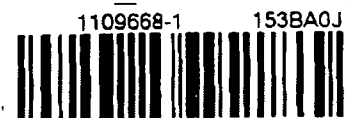

The following Restated Articles of Incorporation duly adopted pursuant to the authority and provisions of chapter 181 of the Wisconsin Statutes supersede and take the place of the existing Articles of Incorporation and amendments thereto

Article 1. The name of the corporation shall be University of Wisconsin Marathon County Foundation, Inc.

Article 2. The period of existence shall be perpetual.

Article 3 The purpose shall be to promote the welfare of the University of Wisconsin Marathon County. In fulfillment of such purpose, the corporation may exercise any and all powers not incompatible with such purpose granted to a corporation under Chapter 181 of the Wisconsin Statutes

Article 4 The corporation is formed exclusively for a nonprofit purpose and no part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its directors, officers or other private individuals. No part of the activities of the corporation shall consist of direct or indirect participation or intervention in political campaigns on behalf of or in opposition to any candidate for public office or carrying on propaganda, or otherwise attempting to influence legislation. Nor shall its primary activity consist of operating a social club for the benefit, pleasure or recreation of any individuals, or carrying on a business with the general public in a manner similar to organizations, which are operated for profit.

Article 5 In the event of voluntary or involuntary dissolution or liquidation of the corporation, any remaining assets of the corporation shall be distributed to, or for the benefit of such organization or organizations designated by the Board of Directors as are then qualified as exempt organizations under Section 501[c][3] of the Internal Revenue Code, as amended.

Article 6 Location of the principal office is 518 South 7<sup>th</sup> Avenue, Wausau, Wisconsin 54401.

Article 7. Name of the registered agent is James D. Koch.

Article 8. Address of the registered agent is 518 South 7<sup>th</sup> Avenue, Wausau, Wisconsin, 54001.

Article 9 This corporation shall have no members and shall be without capital stock

Article 10. The affairs of this corporation shall be managed and directed by the Board of Directors, which shall consist of such number of Directors as shall be fixed by bylaws but shall not be less than three (3). The Board of Directors shall carry out the purposes of the corporation in compliance with its Articles of Incorporation and bylaws. The manner of selection and the terms of office of Directors shall be provided by bylaws


Article 11 These articles may be amended in the manner authorized by law at the time of amendment


