Wisconsin Public Radio (WPR) is a civic and cultural resource which exists to enlighten and enrich the quality of life for people within its listening area. WPR's mission is to serve the entire state of Wisconsin by producing, acquiring and delivering high quality radio programming that serves the public's need to discuss ideas and opinions and that provides cultural enrichment, intellectual stimulation and intelligent, enlightening entertainment throughout the WPR network. WPR reports nearly 500,000 listeners per week and over 54,000 contributors. WPR broadcasts from 34 stations throughout the state and streams live online to provide programs for its 3 networks: the Ideas Network, the NPR News and Classical Music Network, and the 24-hour HD Classical Music Network.

PBS Wisconsin (PBSW) has a mission to boldly enrich, educate and entertain diverse audiences of children and adults through innovative use of television production and broadcasting, other communications technologies and community engagement. PBSW can be viewed on its main channel, the Wisconsin channel, the Create channel, and PBS Kids channel. PBSW serves over 1.4 million people each month. During FY 19, PBSW had approximately 65,000 donors during its most recent fiscal year.
