The 31st annual Conference took place in Indianapolis, Indiana, from September 58, 2018. The Conference welcomed 1,132 artists, artist managers/agents, performing arts presenters, and arts administrators, representing 48 U.S. states and territories and six foreign countries. Arts Midwest manages Shakespeare in American Communities on behalf of the National Endowment for the Arts. During the 20182019 program cycle, we made \$1 million in grants to 40 nonprofit, professional theater companies from 27 states and the District of Columbia to present productions of Shakespeare plays and related educational activities to middle and high school students. We the Many is a pilot program that seeks to expand the understanding of what it means to be a Midwesterner through the creative exchange of voices, cultures, and ideas. The program began its planning phase in 2019 and will co-create yearlong performing arts residencies with Midwestern artists in 20202021 in Wabash, IN; Perry, IA; and Sisseton, SD. Arts Midwest Folkefest engages Upper Midwest audiences in week-long residencies with traditional Nordic musical ensembles. In 20182019, we toured Emilia Amper Band of Sweden to Washington, IA; Marquette, MI; Chisholm, MN; Devils Lake, ND; Aberdeen, SD; and Rice Lake, WI. The ensemble reached more than 2,000 adults and 9,000 children through 65 community, educational, and performance activities. NEA Performing Arts Discovery builds and sustains international arts networks and highlights the diversity of the U.S. performing arts market, with a goal of expanding the global opportunities for performing artists from across the United States. In 2018, 13 arts presenters from Brazil, Chile, China, Colombia, and Mexico attended the Arts Midwest Conference and a follow up forum that explored the arts market in Indianapolis.</p>
