Recognizing that our marketplace has both positive and negative influences, we have a very active Center for Fraud Prevention. We provide fraud prevention education to at-risk consumer populations, specifically senior citizens and the military community. We also offer our community-free Secure Your ID shredding events. Our fraud prevention initiatives include our long-standing partnership with law enforcement representatives in both Minnesota and North Dakota (known as the Coalition Against Marketplace Fraud). We produce and distribute multi-lingual fraud education videos to senior citizens across our state, teach business leaders about investment fraud, teach students about how to protect their savings from scam artists and more!
