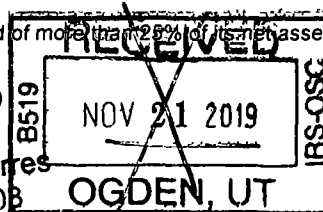

While it is difficult to quantify how many decisions to accept Jesus Christ as Lord and Savior were made, or to what extent an individual listener grew in their knowledge of Christ, the vast majority of our listener letters, notes, emails and phone calls received this past year would indicate that this mission is being fulfilled in the hearts and homes of our listeners. For this progress, we give God all the glory!

2018-19 was another broadcast season showing listener growth through our most recent Christian radio outlets of KJGT 88.3 FM serving Carver and McLeod counties of MN and the south and southwest Minneapolis suburbs through our Bloomington (91.5 FM) and Scott County (106.5 FM) translators).

Additionally, a number of additional radio stations were considered for possible purchase and expansion of the Kinship Christian Radio ministry in the Twin Cities metro area. Once completed in December of 2019, the tower will host the relocation of the current Glenville, MN area Kinship Translator. We were also able to successfully resolve our Hayfield, MN translator operational challenges. We were able to change frequencies and have resumed our fully authorized power of 250 watts and avoid the interference issues that had been plaguing the translator's operation.
