ADDITIONALLY, ANY EVENTS DURING THE FISCAL YEAR THAT GIVE RISE TO THE REQUIREMENT TO DISCLOSE IF ANY CONFLICT OF INTEREST MIGHT EXIST SHALL ALSO BE DISCLOSED UTILIZING THE CIAC. THE FOUNDATION'S PRESIDENT WILL ESTABLISH A CONFLICT OF INTEREST REVIEW COMMITTEE (CIRC) COMPRISED OF TWO BOARD MEMBERS AND THE CFO. THE CIRC WILL REVIEW THE CIAC FORMS AND EVALUATE EACH SITUATION ON ITS OWN MERITS, AND IF A POTENTIAL CONFLICT IS NOTED, WILL INCLUDE A WRITTEN RECOMMENDATION FOR ITS MANAGEMENT. THE ORGANIZATION'S GENERAL LEGAL COUNSEL WILL BE CONTACTED AS THE CIRC DEEMS NECESSARY. ANY MEMBER HAVING AN ACTUAL OR POTENTIAL CONFLICT OF INTEREST ON ANY MATTER CONSIDERED BY THE BOARD SHALL NOT VOTE ON SUCH MATTER. THE MINUTES OF THE MEETING SHALL REFLECT THAT SUCH DIRECTOR DISCLOSED THE INTEREST AND ABSTAINED FROM VOTING.
