COPLAC continued its implementation of a grant from the Teagle Foundation of New York. Four member campuses are sharing courses in Native American and Indigenous Studies using distance technology. The Steering Committee for this grant met in June 2019, and one multi-campus course was offered in Fall Semester 2018, one multi-campus course offered in Spring Semester 2019 and a Summer Field School was conducted in Minnesota in June 2019.

COPLAC also continued its implementation of a series of digital liberal arts seminars through a multi-year grant from the Andrew W. Mellon Foundation. The seminars are team taught and available to students on all COPLAC campuses using distance technology. Three grant-funded classes were offered in Fall Semester 2018 and two in Spring Semester 2019. In addition, student participants made a public presentation about their digital projects at the COPLAC Annual Meeting in Vermont in June 2019.

Eight member campuses sent students, faculty, and staff to the October 2018 Northeast Regional Conference, held in SUNY - Geneseo.
