There were 8 Brown Bag seminars with 238 in attendance. In addition there were two joint ACEC/MN - MnDOT breakfasts with over 150+ in attendance, a client forecasting seminar with 85 in attendance, a series of fundamentals workshops with 32 in attendance, the Minnesota's Transportation Conference with over 1200 in attendance, a series of 4 Women in Engineering presentations with 361 in attendance, a MNSEA Trade Show and Seminar with 108 in attendance and a Building Engineering and Construction Conference with 79 in attendance. A new year long advanced leadership seminar program had 27 in attendance.
