In addition, \$120,000 of fellowships and other grants were paid during the fiscal year.

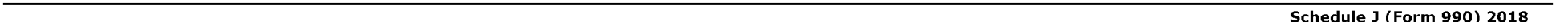
