

Environmental Consulting Services - Primarily engaged in providing advice and assistance to organizations on environmental issues, such as the control of environmental contamination from pollutants, toxic substances, and hazardous materials. Identified problems, measured and evaluated risks, and recommended solutions with multidisciplinary groups of scientists, engineers, and other technicians with expertise in areas, such as air and water quality and site remediation consulting services with regard to the Verde River. Friends operates innovative programs that help keep water in the rivers and creeks of the Verde Watershed. We made significant progress in expanding the Verde River Exchange and initiated a new project, the State of the Verde River Watershed Report Card. Here are some details: The Verde River Exchange sold water offset credits to six buyers, saving over 9 million gallons of water to protect Verde River flows. (Continued - See Sch O)

Environment, Conservation and Wildlife - Primarily engaged in promoting the preservation and protection of the environment and wildlife of the Verde River by addressing issues, such as clean air and water; global warming; conserving and developing natural resources, including land, plant, water and energy resources; and protecting and preserving wildlife and endangered species. Memberships support these causes. Friends restores our ecosystems by removing invasive, non-native plants, mostly from riverbanks and river-adjacent habitats. In FY 19, here are the stats on our work: Our crews treated 804 acres and re-treated 3031 acres to eliminate target invasive plants. We monitored 6438 acres, allowing us to plan for treatments in the future. Over the past two years we created 78 seasonal jobs- 2/3 of which were from underserved and at-risk populations, including military veterans, Native Americans and local community members.

Nature Parks and Other Similar - Primarily engaged in the preservation and exhibition of natural areas or settings of the Verde River. Friends creates community around river conservation by hosting many events throughout the year. In FY 19, here are a few: Wild & Scenic Film Festival; over 200 people attended, in Prescott and Camp Verde, in October 2018. Verde Valley Birding & Nature Festival: over 370 people from 25 states came to Dead Horse Ranch State Park to participate in 55 field trips over three days in April 2019. We raised funds and awarded two youth scholarships for birding-focused summer camp. Over 10,000 volunteer hours were donated during the festival.
