SCHOOL CERTIFICATION PROGRAM IN 2014, SUSTAINABLE JERSEY AND LEADING NEW JERSEY SCHOOL-FOCUSED ORGANIZATIONS SUCH AS THE NEW JERSEY SCHOOL BOARDS ASSOCIATION AND THE NEW JERSEY EDUCATION ASSOCIATION LAUNCHED A FREE SUSTAINABILITY CERTIFICATION PROGRAM CALLED SUSTAINABLE JERSEY FOR SCHOOLS DESIGNED SPECIFICALLY FOR NEW JERSEY PUBLIC SCHOOL DISTRICTS. MODELED OFF OF THE SUSTAINABLE JERSEY MUNICIPAL PROGRAM, THE GOAL IS TO PREPARE THE NEXT GENERATION TO MOVE TOWARDS A SUSTAINABLE FUTURE BY PROVIDING A FRAMEWORK FOR ACTION THAT RESULTS IN A POSITIVE IMPACT ON THE SCHOOL COMMUNITY INCLUDING INCREASED COST SAVINGS, HEALTHIER LEARNING ENVIRONMENTS, AND ENHANCED STUDENT AND STAFF PERFORMANCE. THE PROGRAM INCLUDES NEARLY 100 ACTIONS THAT WERE DEVELOPED USING THE TASK FORCE MODEL EMPLOYED BY THE MUNICIPAL PROGRAM. BY THE END OF 2019, NEARLY 60% OF NEW JERSEY SCHOOL DISTRICTS WERE REGISTERED TO PARTICIPATE IN THE PROGRAM. OF THE 887 SCHOOLS PARTICIPATING IN THE PROGRAM, 241 HAVE ACHIEVED CERTIFICATION INCLUDING 223 AT THE BRONZE LEVEL AND 18 AT THE SILVER LEVEL. SINCE THE PROGRAM'S INCEPTION, NEW JERSEY PUBLIC SCHOOLS HAVE COMPLETED AND DOCUMENTED OVER 5,000 SUSTAINABILITY ACTIONS. SUSTAINABLE JERSEY ENTERED INTO A MASTER SERVICES AGREEMENT WITH THE COLLEGE OF NEW JERSEY TO RECEIVE ONGOING SERVICES AND FACILITATE CERTAIN SUSTAINABLE JERSEY GRANTS. AS PART OF THE ONGOING SERVICES RECEIVED, IT IS ESTIMATED THAT THE COLLEGE OF NEW JERSEY DONATED \$12,911 IN CONTRIBUTIONS AND EXPENSES RELATED TO THIS PROGRAM.
