Great Promise Partnership has many high schools engaged in various stages of implementation. Once the school is involved we just need an employer. Getting employer participation is the hardest part of implementation. There are approximately 300 positions promised to GPP students by participating businesses for the 2017/18 school year. That's an increase of approximately 200 new positions, and that number is expected to continue growing throughout the 2018-19 school year.
