For program endowments, there are two different methods used. Some programs have "budget managers" who are aware of the funds available via the business office staff and spend accordingly. For those programs without "budget managers and for unrestricted endowments, the business office staff ensures that there are expenses incurred in those specific departments before drawing down actual dollars.
