Safe Harbor staff can be contacted via telephone 24 hours a day, 7 days a week, 365 days a year. The Organization shelters victims and children of domestic violence for a temporary period of time while they are looking for a new, safe place to live. The Organization also provides advocacy services for victims of domestic violence, sexual assault, bullying, and stalking. In FY2019, Safe Harbor assisted women, children and men that were victims of domestic violence. Safe Harbor also assisted 241 stalking victims, 110 sexual abuse victims, 22 adolescent sexual abuse victims, 50 child abuse victims, 64 domestic violence protection orders, and 21 stalking protection orders. The Organization sheltered 59 women and 51 children, providing 3,960 bed nights and 11,880 meals.

Form 990, Part III, Line 4b:

Kids Konnection served as a supervised visitation and exchange center for individuals referred by a court system, Department of Social Services, attorneys or others if there are difficulties exchanging children with another caretaker including when a court order restricts contact between parents or emotional safety is compromised. In fiscal year 2019, there were 110 supervised child exchanges and 1,344 hours of supervised visitation.
