

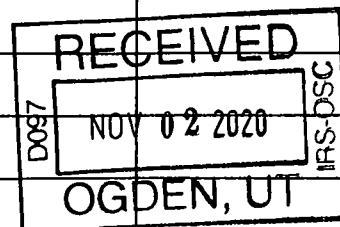

Grace Missions, Inc. provides spiritual, operational, medical and financial support for Grace School in Koro, Mali, which provides Christian based primary and middle school education in an impoverished area of a very poor country. Grace Missions has helped build a new school building educating over 400 local children in grades K-9, supplied much of the operating budget, provided jobs for indigenous teachers and construction workers and brought hope to many families who otherwise would not have been able to send their children to a quality school. In 2019 Grace School was expanded by adding Kindergarten and 9th grades as well as providing health assessments and needed medications to all students. Grace School also provides free water to a significant percentage of the town during the dry season. Additional land has been purchased for Grace High School for grades 10-12, and construction of additional facilities began in 2019. Long term plans call for vocational and technical training for high school graduates.
