Private classes are offered to organizations in the disciplines of their choosing. These are often enrichment classes for elementary to secondary students. Students gain confidence and skills to inspire them to explore available careers in industrial arts. Forty youth attended. High school students attended a Spring semester and 4-5 graders attended a Fall session.

**Explanation:** A timely request was filed for an extension to complete the return for Fiscal Year 2018-19 due on July 15, 2020. Our nonprofit is run solely by volunteers (excepting some instructors), and our volunteer did not have adequate access to the facility and physical files while the building was locked down to comply with local restrictions in response to COVID19. We believed the return was ready to submit on time, but while doing the final review it was realized that the prior volunteers had not recorded capitalized asset acquisition, depreciation, and disposition correctly going back a couple years (prior returns will be amended). Extra time was needed to search the file boxes for this information, and amend both the Statement of Activity as well as the Statement of Position, thus requiring the return to be reworked entirely. Then it was discovered that our H&R Block software was for the 2019 tax year (Our fiscal year ends June 30 2019 which can be confusing). This current online software, form990online.org, would not allow filing until all errors were corrected, which required additional review. The return is being filed today with an additional adjustment, which we will correct and amend as needed. Future late filings should be ameliorated by the recent addition of a new Director with a Business degree and accounting experience. The new Board of Directors will explore outsourcing bookkeeping as soon as the losses of revenue resulting from the COVID19 experience have been examined and a new budget is developed. Meanwhile, a full review of past returns and adjustments to accounting procedures and calendars will be implemented. Going forward, all past records will be corrected and returns amended if needed. We will continue to use this online program so each year will be carried forward and help eliminate errors. Please consider abating any penalties we might otherwise have incurred. Thank you.
