These projects include free vision clinics, life jackets stations, anti-bullying programs, student enrichment grants to classrooms, breast cancer awareness, disabilities awareness, support to local fire and search & rescue departments, anti-tobacco use, drunk driving education, campus closets, teaching elementary students about money management, day of service to help beautify their communities, and Project GAP (Graduation Assistance Program).

Teach high school students about non-profits, provide leadership in running a business by serving as officers and on the board of directors, project management experience performing their community service projects, grant writing and fundraising to fund their projects, and life skills such as public speaking, working with community and political leaders, and getting exposure to business leaders and possible career opportunities.

Josephine County has been named "Oregon's least educated County" by the State based on the percent of the population with a college degree. JCF operates a competitive scholarship program designed to provide financial aid to students pursuing a four-year or two-year college degree, or attending a certified technical school. The goal of the scholarship program is for recipients to get a college degree and return to Josephine County for their careers.
