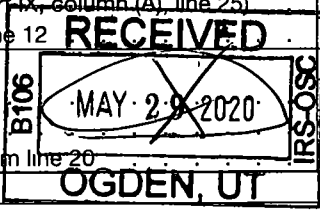
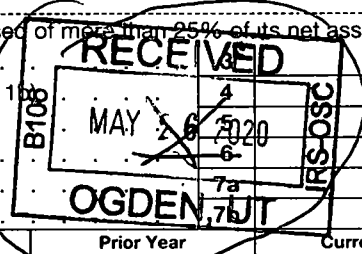

1. Talent show productions to promote creativity and encourage cooperation among students, staff/faculty, and parents.
2. Gym/activity nights to promote physical fitness by encouraging students to come together in an active manner after school hours.
