Donations to the Agricultural Society included \$25,000.00 from the Phelps County Board of Supervisors and \$50,440.00 from Phelps County Community Foundation to use towards cost of residing and insulating the Phelps County Agricultural Center, the office building at the fairgrounds which was built in 1974. Open Class special awards were provided thanks to individuals and businesses with donations of \$245. Persons parking their campers at the fairgrounds during the fair donated \$1000 for that privilege. The Phelps County Community Foundation held a one-day give2Crow activity that brought in donations of \$2,787.70 for improvements in the sidewalks and parking lot at the Ag Center in Holdrege. \$3,620 in gifts were received by others for the fair auction breakfast, use of bleachers and the trailer, and other activities.
