During the year ending June 30, 2005, the Council was the recipient of additional Community Development Block Grant funds in the amount of \$203,565. The funds had been received by the County in an earlier year and awarded to another entity before being remitted to the Council. The funds are invested in money market accounts and are stated at cost with interest added annually. The Grant provisions restrict all funds with the exception of 18% of the annual earnings. The Council is allowed to use the restricted funds for economic development projects in accordance with grant re-use provisions.
