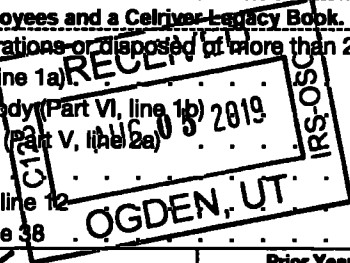

**Construction of a Celriver Legacy Plaza**  
Construction of the Plaza was completed in November 2017. This was the major effort of the program services. Additional names were added to the pavers in this fiscal year.  
Total design and construction cost of the Plaza was \$233,156.51 from 2015-2019.

**Publication and sale of a Celriver pictorial memory book.**  
Sale of the book continued with \$390 received this fiscal year.  
We have still have an inventory of unsold books of \$8,715 valued at cost. We have been unable to sell the remaining books and we have ceased operations effective June 28, 2019. Therefore, we are writing off the value of the books to \$0.

4c (Code: ) (Expenses \$ 51,065 including grants of \$ ) (Revenue \$ )  
**Establish endowed scholarships at Winthrop University and York Technical College primarily towards children and grandchildren of former Celriver employees.**  
An agreement was reached and finalized with Winthrop University last fiscal year for a \$25,000 endowed scholarship that will provide a \$1,000 scholarship each year for the foreseeable future. Last fiscal year \$1,000 was donated to this fund. This year the Celriver Legacy Project donated \$24,232 to this fund and \$1,600 was donated to the fund directly by Winthrop alumni making a total of \$26,832 in the fund. This will allow a \$500 scholarship to be awarded for the fall 2019 semester and \$500 each semester thereafter.  
An agreement was reached and finalized with York Technical College this fiscal year for a \$25,000 endowed scholarship that will provide a \$1,000 scholarship each year for the foreseeable future. Celriver Legacy Project donated \$26,832 to this fund which will allow a \$500 scholarship to be awarded for the fall 2019 semester and \$500 each semester thereafter.
