The Northwest Regional Adult Drug Treatment Court served 42 individuals in FY18. One client successfully completed the program. Thanks to a grant from the United Way of the Northern Shenandoah Valley the NSVSAC was able to connect certified peer recovery specialists to 471 local residents who are living with addiction. With a powerful message of hope combined with the experience of success in their own recovery, peer recovery specialists serve as life coaches, extending the clinical reach of treatment and going directly into the lives of people who need them most. The peers assist the individuals with creating a Wellness Recovery Action Plan to identify goals and develop a plan to prevent substance use.

The focus of this fiscal year for the Law Enforcement Overdose Intervention Program (LEOIP) has been on the implementation of the program. This program is mobilizing a multi-disciplinary team consisting of a therapist/case manager, Certified Peer Recovery Specialist, and a law enforcement officer. The law enforcement officer began working, was trained on being a member of the Task Force, and began responding to non-fatal overdoses. We created the handbook, treatment forms, and a brochure which describes the LEOIP program. Four community events were held with a total of 760 attendees. The Executive Director of the NSVSAC completed 13 presentations including a presentation at the National Rx Drug Abuse and Heroin Summit in Atlanta on "A Comprehensive, National Emerging Drug Threat Initiative: An Early Warning System for the Country."

During this fiscal year the NSVSAC launched the "Give Me a Reason Drug Prevention Initiative" program. During the "Play for Prevention" event on April 1, 2019 the drug testing kits were handed out to local parents. In addition, a video, featuring local parents discussing the importance of talking to their kids about drugs and drug screening their children, was released. The NSVSAC partnered with 13 sites throughout the community where parents can pick-up the drug testing kits. All Winchester Public School counselors, Winchester Department of Social Services employees, and representatives from local law enforcement were trained on SBIRT (Screening, Brief Intervention, and Referral to Treatment). Since its implementation 178 kits have been distributed to local parents. A landing page on the Road to Recovery website was created which details the program and the distribution site locations.

1. Give Me a Reason Drug Prevention Initiative. The NSVSAC received a grant from Rotary International for the Give Me A Reason Drug Prevention Initiative. This program has three goals which include identifying substance use among youth, compassionately intervening before more severe consequences occur, and providing funding to treatment. To identify substance use among teens the program provides free saliva-based drug testing kits to parents and caregivers who suspect substance use by their teens. Local school counselors and Department of Social Services employees were trained on SBIRT (Screening, Brief Intervention, and Referral to Treatment), an evidence-based approach to identify patients who use alcohol and other drugs at risky levels. Finally, the initiative will provide funding for eligible youth who are referred to treatment, but do not have insurance or the means to pay for it. 2. Aetna LEOIP Program. The NSVSAC received a grant from CVS Health/The Aetna Foundation for the Law Enforcement Overdose Intervention Program (LEOIP). This program is mobilizing a multi-disciplinary team consisting of a therapist/case manager, Certified Peer Recovery Specialist, and a law enforcement officer. This team responds to non-fatal overdoses in our area and offers individuals treatment rather than incarceration. One of the goals of the program is to reduce the number of individuals, in our community, who are dying from an opioid or heroin overdose. The program aims to support intervention, diversion, and
