The mission of the foundation is to raise funds and provide resources for the educational enrichment of students and staff in the Middleton-Cross Plains Area School District (MCPASD).

Inspiration Grants: Grants are awarded to schools in the MCPASD school district to provide inspiring learning experiences for students and staff. This year, applications were submitted by students and staff from six district schools. The applications were reviewed by a committee of foundation board members. Ten were selected and awarded in April, 2019, ranging from \$500 to \$2,500 each. Also awarded was a stipend of \$1,500 for a staff member serving on the Caldecott Award selection committee.

4b (Code:) (Expenses \$ 6,544 including grants of \$ 6,544) (Revenue \$ -0-)

Supported Fundraising: The foundation also serves as a collection point for funds solicited by school groups that lack the means to easily raise funds on their own. Solicitations and use of the funds must be in accordance with the foundation's stated mission. Services provided include collecting funds (use of deposit account and PayPal), invoicing, and disbursement (check writing, use of debit card, etc.). School groups must be operating under the auspices of the school district.

Scholarships: Provided to graduating high school seniors to pursue post-secondary education. Application for one four-year, \$500 renewable scholarship is open to any graduating senior from the two district high schools and the district-sponsored online school. Application for two \$500 nonrenewable scholarships are open to graduating students who profess interest in health careers. Applications are reviewed by a community-based board chaired by one of Middleton High School's deans.
