The Center does not expect the total amount of unrecorded tax benefits to significantly change in the next 12 months. The Center recognizes interest and/or penalties related to income tax matters in income tax expense. The Center did not have any amounts accrued for interest and penalties at June 30, 2019 and 2018. At June 30, 2019 and June 30, 2018, the Center has not recorded any expected tax benefits.

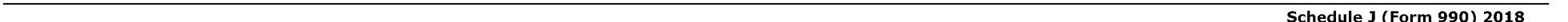
