MidAmerica Nazarene University is a private, Christian, liberal arts university founded in 1966. The campus is located on 105 acres in Olathe, Kansas. In 2016, MNU had its accreditation by the Higher Learning Commission reaffirmed. Offering over 40 undergraduate majors, the university is also known for its accelerated professional and graduate programs, including undergraduate degrees in management, education, computer information systems, and nursing and graduate degrees in business, education, nursing, and counseling, and postgraduate certificates. Chapel services and other opportunities for spiritual deepening provide an emphasis on students' spiritual formation. Total enrollment for the Fall 2018 semester was 1,882 students. The five largest undergraduate programs were Nursing, Organizational Leadership, Business Administration, Elementary Education, and Kinesiology.
