(Plan) carried out 168 disaster responses globally ranging from localized responses to large scale national and regional emergencies. 33 education in emergency programs were carried out across 23 countries and 38 child protection in emergency programs were carried out across See Part III, Ln 4a statement

Healthy Start in Life:

Plan supports a range of activities aimed at reducing neonatal and maternal mortality and increasing child survival and the healthy development of children. This includes building and equipping pre-school centres and clinics and the promotion of universal birth registration, the training of health workers and the prevention of early childhood illnesses. During the year ended June 30, 2019 Plan's early childhood development programs reached 18,799,660 girls, boys, women and men.

Quality Education:

Plan seeks to promote free equal access to quality education and life-skills training to help children and young people reach their full potential. 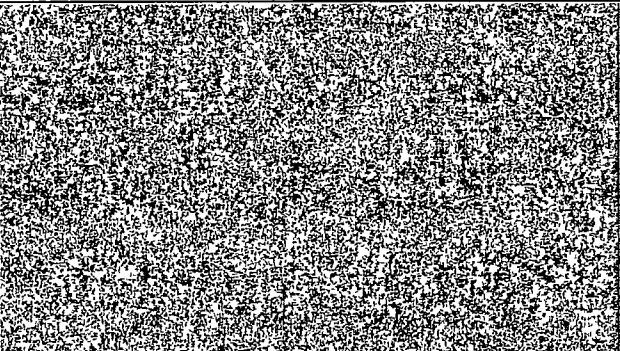

Projects that are funded by grants received from third party donors will also be subject to scrutiny via reporting specified by the donor. Such reporting is typically quarterly and such projects may also be subject to external audit on behalf of the donor. Finally, Plan's external auditors review project spending as part of the annual financial statement audit process.
